## General Session Speakers



Dr. Shirley D. McCune has worked as a classroom teacher, university faculty member, educational researcher, education association manager, and federal executive. Dr. McCune is a Senior Director with the Mid-continent Regional Laboratory (McREL) (a non-profit institution committed to helping state agencies and local schools restructure themselves to increase school efficiency, effectiveness, and relevance) and Director of the McREL Center for

Educational Equity. Dr. McCune is responsible for the supervision of work with state-level decision makers on school improvement and equity issues.

Dr. McCune received her undergraduate degree from the University of Northern Colorado at Greeley; her master's degree from the University of Denver, and her doctorate degree from Catholic University of America. She has worked with the National Education Association, the Council of Chief State School Officers, the U.S. Department of Education, and the Education Commission of the States.

Dr. McCune has authored or co-authored research reports, articles, training models, and monographs. She is an experienced conference planner and trainer and has worked with educators, state leaders and legislators, business organizations, and federal agencies.



Dr. Anne Campbell has demonstrated her commitment to quality education throughout her career. She is well known to Nebraskans particularly through her tenure as the Commissioner of Education for the Nebraska Department of Education from 1974 to 1982. Dr. Campbell also served as the County Superintendent of Schools in Madison, Nebraska, for eight years and worked as Director of Public Affairs for the University of Nebraska.

Dr. Campbell received her undergraduate degree from the University of Northern Colorado at Greeley; her master's degree from Wayne State College in Nebraska, and her doctorate degree from the University of Nebraska-Lincoln.
