TEACHING EXPERIENCE

University of Nebraska-Lincoln, 2003-Present

- **Medical Aspects (SLPA-897M)** – The content of this course included aspects of medical practice in speech-language pathology consisting of reimbursement principles, terminology, medical record management, basic understanding of trachs and vents, medical report writing, basic understanding of laryngectomy management, and practice within various treatment settings including acute care, skilled nursing, and outpatient rehabilitation. This course was taught for seven years. It is no longer part of the curriculum.
- **Differential Diagnosis (897D)** – The content of this course included principles of evaluation and assessment as related to standardized testing, report writing, psychometrics, and the conduct of evaluation sessions. Additionally, this course reviewed the specific assessment measures and techniques common in speech-language pathology practice. This course was taught for seven years. It is no longer part of the curriculum.
- **Evidence-Based Practice (SLPA 870)** – The content of this course focused on the understanding of evidence-based practice in the field of speech-language pathology. The course emphasized a multifactorial approach to evidence-based practice that includes the external evidence (research), internal evidence (clinical practice results), and client values. Various taxonomies of evidence were discussed, and students were asked to analyze research articles for rigor while balancing client and clinical factors to determine applicability. The course was taught in the summer session from 2011 to 2014.
- **Clinical Decision-Making (SLPA 893)** – The content of this course included basic clinical processes related to assessment and treatment. Clinical decision-making, within clinical processes, was addressed.

Topics included, data collection, identification of treatment techniques, treatment and assessment planning, clinical writing, and implementation of functional behavioral objectives. The course was offered in the fall semester and was taught from 2010 to 2017.

- **Right Hemisphere Dysfunction (SLPA-986)** – The course content examined the communication and cognitive characteristics associated with damage to the non-language dominant hemisphere of the brain. Theories of right hemisphere dysfunction, modality-specific deficits, assessment issues and procedures, and treatment principles and paradigms were presented. The course was offered in spring as an elective and was taught 2018 to 2020. The content of this course was moved to be included in another course in the curriculum.
- **Augmentative and Alternative Communication (SLPA 486/886)** – The content of this course covered AAC across the lifespan and across severity of disorder. A lab component was included within the course, which included speech generating devices, apps, mid-tech technology, and assistive technology software. The lab is taught by a clinical faculty member but overseen by the course instructor. The course focused on evidence-based practice in AAC. The course was taught in the fall semester 2015 to 2019. The course has been team taught since 2019 with equal responsibility for the course split between two instructors. As of fall 2020 the course has been offered twice a year and is required course for Special Education Majors. It is variable credit and a graduate/undergraduate course.
- **Clinical Practicum Course (897-B)** – The content of this course supplements the clinical practicum experience. Topics address specific speech and language topics, aspects of clinical process, aspects of the supervisory process, as well as professional developments skills and wellness. Guest lecturers are used to supplement the material presented in the course. The course has been taught fall, winter, and summer sessions since fall of 2014.
- **Dementia (SLPA-988)** – The course content examined the etiology, characteristics, assessment, and intervention pertaining to cognitive and communication disorders associated with various types and stages of dementia. The course is offered in spring as an elective and has been taught since 2018.
- **Aphasia (SLPA-987)** – This course content examined the etiology, characteristics, assessment and intervention of individuals with acquired language impairment in aphasia. The course was a required course and was offered every fall. It was taught as a required course 2018 to 2020. Beginning spring of 2020 this course is taught as an elective.
- **Cognitive and Language in Adults (SLPA-862)** – This course was team taught with Dr. Weissling serving as lead instructor of the course. The content of the course includes information on neuroimaging, aphasia, right hemisphere disorders, traumatic brain injury, dementia, and adults with developmental disabilities. Disordered and normal processes are reviewed. Dr. Weissling is responsible for coordination and presentation of the sections on aphasia and dementia.
- **Other courses team-taught** – In 2020 the curriculum was updated to include more team-taught courses. In addition to the courses listed above Dr. Weissling contributes teaching units to Clinical Decision Making I (SLPA-874) (three units) and Clinical Decision Making II (SLPA-875) (two units).

Nova Southeastern University, Fort Lauderdale, FL, 2003-Present (adjunct online)

- **Cognitive Communication Disorders in Adults (SLP 6021)** – The content of this course covered the processes of cognition that influence communication in the adult with acquired brain injury. Topics included attention, memory, concept formation, problem solving, reasoning, and executive function. Additional topics included community re-entry and vocation rehabilitation. Co-taught with pediatric cognition instructor. Course is two independent parts.
- **Language Disorders in Adults** – The content of this course included diagnosis and treatment of acquired neurogenic communication disorders including aphasia, right hemisphere damage, dementia, and traumatic brain injury. This course was taught online 2003 to 2021.

Nova Southeastern University, Fort Lauderdale, FL, 1996-2003

- **Cognitive Communication Disorders in Adults** – The content of this course covered the processes of cognition that influence communication in the adult with acquired brain injury. Topics included attention, memory, concept formation, problem solving, reasoning, and executive function. Additional topics included community re-entry and vocation rehabilitation. This course was developed and taught for five years on campus.
- **Clinical Processes** – The content of this course covered basic processes inherent in the treatment of

people with communication impairments. Topics included, case review, behavior management, use of cues, planning, clinical writing, and implementation of functional behavioral objectives. This course was taught for three years on campus.

- **Technology Applications in Speech-Language Pathology** – The content of this course included a variety of topics surrounding the use of technology in the practice of speech-language pathology including: voice instrumentation, augmentative communication, use of electronic library services, use of internet resources, use of web-based instruction software, and use of clinical application software. This course was taught for two years on campus.
- **Language Disorders in Adults** – The content of this course included diagnosis and treatment of acquired neurogenic communication disorders including aphasia, right-hemisphere damage, dementia, and traumatic brain injury. This course was taught for seven years live on-campus.
